

**TVA EnergyRight Summer Sweepstakes
Official Rules**

- **NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND DOES NOT INCREASE YOUR CHANCES OF WINNING.**
- **VOID OUTSIDE THE ELIGIBILITY AREA AND WHERE PROHIBITED BY LAW.**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE SWEEPSTAKES PARTIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The TVA EnergyRight Summer Sweepstakes (the “Sweepstakes”) is open only to legal residents of the United States residing in eligible ZIP Codes within the Tennessee Valley Authority service area located in the states of Alabama, Georgia, Kentucky, Mississippi, North Carolina, Tennessee, and Virginia (the “Eligibility Area”) (see Appendix A for eligible ZIP Codes), who have reached the age of majority in their state of residence as of the date of entry. Entrants must be physically residing within the Eligibility Area at the time of entry. Employees, officers, and directors of Tennessee Valley Authority (“Sponsor”), Red Sage Communications, Inc., Red Pepper, ClearResult Consulting, Inc., Realtime Media LLC (“Administrator”), and their respective parent companies, affiliates, subsidiaries, advertising, promotion, fulfillment, and marketing agencies (collectively, the “Sweepstakes Parties”), and their immediate family members and persons living in the same household as such individuals (whether related or not), are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, “immediate family members” means spouse, partner, parents, legal guardians, children, siblings, grandparents, grandchildren, and each of their respective spouses. “Household members” means individuals who share the same residence for at least three (3) months per year, whether related or not. Void outside the Eligibility Area and where prohibited or restricted by law. By participating in the Sweepstakes, each entrant fully and unconditionally agrees to and accepts these Official Rules and the decisions of the Sponsor and Administrator, which are final and binding in all matters relating to the Sweepstakes.
2. **TIMING:** The Sweepstakes begins at or about 9:00:00 a.m. Eastern Time (“ET”) on July 15, 2026, and ends at 11:59:59 p.m. ET on August 31, 2026 (the “Sweepstakes Period”). The Sweepstakes is comprised of eight (8) entry periods (each, an “Entry Period”), as set forth in the table below. The Sponsor’s computer is the official time-keeping device for the Sweepstakes.

Non-winning entries **will** carry forward to subsequent Entry Periods. The designated computer clock of the Sponsor is the official time-keeping device in the Sweepstakes.

3. **HOW TO ENTER:** There are two (2) ways to enter the Sweepstakes:

A. DIY HOME ENERGY ASSESSMENT METHOD OF ENTRY: During the Sweepstakes Period, visit <https://energyright.com/retreat-from-the-heat> (the "Website") and follow the instructions to access and complete the DIY Home Energy Assessment ("DIY HEA"). You will be required to complete and submit the requested registration information, which may include your full name, mailing address (no P.O. Boxes), phone number, email address, and the name of your local power company. Upon successfully completing the DIY HEA during the Sweepstakes Period, you will receive one (1) entry into the applicable Entry Period drawing, subject to the limits set forth below.

Upon successful completion of the DIY HEA, participants will receive one (1) energy savings kit and one (1) \$10 gift card, while supplies last. Receipt of the energy savings kit and gift card is not contingent upon winning a prize in the Sweepstakes.

B. HOME ENERGY EVALUATION METHOD OF ENTRY: During the Sweepstakes Period, eligible individuals who have previously completed a DIY HEA may instead schedule and complete a Home Energy Evaluation ("HEE") through the Website. Upon successfully completing an HEE during the Sweepstakes Period, you will receive one (1) entry into the applicable Entry Period drawing, subject to the limits set forth below.

Upon successful completion of the HEE, participants will receive one (1) energy savings kit, while supplies last. Receipt of the energy savings kit is not contingent upon winning a prize in the Sweepstakes.

The total number of energy savings kits and gift cards available for distribution is limited and will be fulfilled on a first-come, first-served basis in the order in which eligible entries are received. Sponsor makes no guarantee that a kit or gift card will be available for every entrant and expressly reserves the right, in its sole and absolute discretion, to limit the number awarded, to substitute an item of comparable or greater value, or to decline to award a kit or gift card once supplies are exhausted.

C. ALTERNATE MEANS OF ENTRY ("AMOE"): To enter without completing a DIY HEA or HEE, hand-print your full name, complete mailing address, email address, phone number, and date of birth on a plain 3" x 5" card and mail it in a hand-addressed envelope with proper postage affixed to: Realtime Media, Attn: TVA EnergyRight Summer Sweepstakes Entry (12753), Realtime Media LLC, 2460 General Armistead Ave, Suite 209, West Norriton, PA 19403. Mail-in entries must be postmarked by the applicable Entry Period End Date and received by the corresponding Mail-In Entry Received By Date identified in Section 2 in order to be eligible for the applicable Entry Period drawing. No photocopied, mechanically reproduced, or mass-produced entries will be accepted. Sponsor and Administrator are not responsible for lost, late, incomplete, illegible, misdirected, damaged, or postage-due mail-in entries. Each eligible mail-in entry will receive one (1) entry into the applicable Entry Period drawing, subject to the limits set forth below.

The energy savings kits and gift cards described above are participation incentives and are not part of the Sweepstakes prize pool. The Sweepstakes Parties are not responsible for technical, electronic, telephone, hardware, software or network, computer or data transmission errors, malfunctions, or difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

LIMIT: There is a limit of one (1) entry per household during the Sweepstakes Period, regardless of method of entry or promotion path (DIY HEA or HEE). Attempts made by the same individual to earn more than the stated number of entries by using multiple or false contact information, accounts or otherwise may result in disqualification. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. Entries that are in excess of the stated limit, incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late or misdirected, deceptive or otherwise not in compliance with the Official Rules may be disqualified from the Sweepstakes at Sponsor's sole and absolute discretion. Those who do not follow all instructions, provide the required information in their entry form, or abide by these Official

Rules or other instructions of Sponsor may be disqualified. Entries submitted by those who do not meet the eligibility requirements (including all requirements with respect to age and residence) are void. All materials submitted become the physical property of Sponsor and will not be returned. In the event of a dispute over the identity of an entrant, entry will be deemed submitted by the registered account holder of the email address associated with the entry for the domain associated with the submitted address, provided that person is eligible. Winners may be required to show proof of being the registered account holders/customers. Registered account holder is defined as the person assigned to an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses. In the event that a dispute regarding the identity of the individual who submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry will be deemed ineligible.

4. **SWEEPSTAKES DRAWINGS:** On or about each of the Random Drawing Dates set forth in Section 2 above, the Administrator will select five (5) potential weekly prize winners in a random drawing from among all eligible entries received for the applicable Entry Period in accordance with these Official Rules.

On or about September 10, 2026, the Administrator will select two (2) potential Grand Prize winners in a random drawing from among all eligible entries received during the entire Sweepstakes Period in accordance with these Official Rules.

5. **ODDS:** Odds of winning a Weekly Prize depend on the total number of eligible entries received for the applicable Entry Period. Odds of winning a grand prize depend on the total number of eligible entries received for the entire Sweepstakes.
6. **WINNER NOTIFICATION:** The potential winners will be notified via email using the information provided on the entry form in a commercially reasonable time after the applicable drawing. The Sweepstakes Parties are not responsible for and shall not be liable for false, incorrect, changed, incomplete, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, insufficient space in an entrant's email account, or late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon the sending of an email. If a potential winner cannot be contacted, is ineligible, if any notification is returned as undeliverable, or if a potential winner fails to respond within five (5) business days of notification or otherwise fails to fully comply with these Official Rules, the applicable potential winner will forfeit the prize and an alternate winner may be selected, up to three (3) alternates, from among all remaining eligible entries received for the applicable Entry Period (for a Weekly Prize) or the Sweepstakes Period (for a Grand Prize), after which the applicable prize will remain unawarded. A potential winner becomes a "winner" only after verification of eligibility by Sponsor. No more than the stated number of prizes will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of prizes set forth in these Official Rules, the winners of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
7. **PRIZES/PRIZE RESTRICTIONS:** The prizes to be awarded in this Sweepstakes are:

Two (2) Grand Prizes: Each "Grand Prize" is a prize package consisting of one (1) power strip, one (1) set of smart plugs, one (1) thermostat, one (1) Dyson Cool AM07 Fan, one (1) Nintendo Switch 2 with one (1) game selected by Sponsor, and one (1) 75-inch Samsung television. Exact makes, models, colors, game title, and other prize details will be determined by Sponsor in its sole discretion. The approximate retail value ("ARV") of each Grand Prize is \$1,927.27.

Thirty-Five (35) Weekly Prizes (five [5] awarded per Entry Period): Each "Weekly Prize" is an ecobee Smart Thermostat. The ARV of each Weekly Prize is \$150.00.

Total ARV of all prizes available in the Sweepstakes: \$9,104.54.

Prizes are non-transferable, with no cash redemptions, equivalents, or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and are subject to prize provider's rules and restrictions. In the event that Sponsor is unable to provide a prize or prize component, the Sponsor may elect to provide winners with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The ARV of the prizes is based on available information provided to Sponsor as of the time these Official Rules are printed and may fluctuate. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prizes or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Sweepstakes Parties will have no further obligation with respect to that prize or portion of the prize. The Sweepstakes Parties are not responsible for, and winner will not receive the difference, if any, between the actual value of the prizes at the time of award and the stated ARV in these Official Rules or in any Sweepstakes-related correspondence or material. Limit of one (1) Sweepstakes prize per household. Sponsor will attempt to fulfill all properly claimed prizes within approximately four (4) to six (6) weeks after winner verification.

8. **GENERAL:** Subject to applicable law, each winner hereby expressly grants to the Sweepstakes Parties and their respective successors, assigns, sublicensees and designees, the irrevocable right to use and publish his/her name, social handles, likeness (photographic or simulated), voice, biography and place of residence for all purposes, including, without limitation, advertising, marketing, promotional and publicity purposes in connection with this Sweepstakes ("Advertising"), in any and all media now or hereafter devised, worldwide, in perpetuity, without any form of notice, permission or any amount or kind of compensation, except for the awarding of the prizes to the winners. All copyright, trademark or other intellectual property rights in such Advertising shall be owned by Sponsor and/or its licensors, and each winning entrant hereby disclaims and waives any claim of right to such Advertising. Such Advertising shall be solely under the control of Sponsor and/or its licensors, and each winner hereby waives any claim of control over the Advertising content as well as any possible claims of misuse of such winning recipient's name, likeness or voice under contract, tort or any other theory of law. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an unsportsmanlike manner.
9. **CONDUCT:** The Sweepstakes Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. The Sweepstakes Parties reserve the right, at their sole discretion, to disqualify any individual found to be tampering with the participation process or the operation of the Sweepstakes, or to be acting in any manner deemed by the Sweepstakes Parties to be in violation of the Official Rules, or to be acting in any manner deemed by the Sweepstakes Parties to be unsportsmanlike or disruptive, or

with intent to annoy, abuse, threaten or harass any other person and void all associated Entries and/or registrations. CAUTION: ANY ATTEMPT BY A USER, YOU OR ANY OTHER INDIVIDUAL TO DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, THE SWEEPSTAKES PARTIES RESERVE THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW. Sponsor reserves the right, at its sole and absolute discretion, to disqualify (or terminate the prize of) any individual who is found to be, or suspected of, acting in violation of these Official Rules, or to be acting in an unsportsmanlike, obscene, immoral or disruptive manner, or with the intent to annoy, abuse, threaten or harass any other person.

10. **WAIVERS AND DISCLAIMERS:** The Sweepstakes Parties assume no responsibility or liability for: (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or garbled registrations, entries, URLs, or emails; (b) any incorrect or inaccurate entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of entries or registrations at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (e) inaccessibility or unavailability of the Internet or the website or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, social networking posts, or registrations, the announcement of the prizes, or in any other Sweepstakes-related materials; or (f) any injury or damage to entrants or to any other person's computer which may be related to or resulting from any attempt to participate in the Sweepstakes. 11. **RELEASES:** All entrants, as a condition of participation in this Sweepstakes, agree to release, discharge, indemnify and hold harmless the Sweepstakes Parties and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees), losses, damages, fines, or actions of any kind whatsoever for injuries, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) entrant's registration material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.
12. **GOVERNING LAW AND LIMITATION OF LIABILITY:** Except where prohibited, all issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrants or winners, Sponsor, and Administrator in connection with this Sweepstakes, shall be governed by, and construed in accordance with, the Federal laws of the United States, and to the extent not inconsistent therewith, the laws of the State of Tennessee, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Tennessee or any other jurisdiction), which might otherwise cause the application of the laws of any jurisdiction other than the State of Tennessee. Any action seeking legal or equitable relief arising out of or relating to the Sweepstakes or these Official Rules shall be brought only in the Federal Court for

the Eastern District of Tennessee. You hereby irrevocably consent to the personal jurisdiction of said courts, waive any claim of forum non-convenience or lack of personal jurisdiction you may have, and waive any right to a trial by jury.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

13. **TAX INFORMATION:** All federal, state, local, and other taxes on prizes and any other costs and expenses associated with prize acceptance and use not specified herein as being provided, are the sole responsibility of the applicable winner.
14. **PRIVACY:** As part of the Sweepstakes entry process, Tennessee Valley Authority and/or its partners will be collecting personal data about entrants on the Website, in accordance with its privacy policy. By participating in the Sweepstakes, you are agreeing to Tennessee Valley Authority's collection and usage of your personal information and acknowledge that you have read and accepted these privacy policies. When you enter via the Website, you may be asked to consent to receive promotional emails and reminders for upcoming promotions and information about Tennessee Valley Authority. These consents are all voluntary and do not have to be agreed to for entrance into the Sweepstakes, nor will it improve your chances of winning.
15. **MISCELLANEOUS:** The invalidity or unenforceability of any provision of these Official Rules will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
